**Reading and Disposal of any Unapproved Minutes:** Pam Anderson made a motion to approve the unread minutes of the BOD meeting of April 29, 2019. Laura Gunn seconded and all voted to approve.

**MANAGER'S REPORT:** Natalie Poland reported that one violation letter was sent out. Clayton Preston is completing roof Wind Mitigation for the insurance company. She has been working on getting proposals for cable service that is due to expire in September. We are soliciting bids for lawn care.

**TREASURER'S REPORT:** Bobby Coogler reported that as of 4/30/19 our funds were:

Operating Cash \$ 334,013.49 Insurance Fund \$115,465.50 Reserve Fund \$183,506.20

**PRESIDENT'S REPORT:** Pam Anderson did a recap of the goals of this BOD, and how they are being met. We are getting bids for tree trimming and removal in preparation for hurricane season. The two trees behind 1406 Cara Dr. have been removed. Pam explained about the meaning of "common element" in a condominium, and stated that any renovations done to common elements must have written board approval in advance.

## **NEW BUSINESS:**

**TERMITE TENTING:** We will complete our termite tenting in July thereby having all buildings under warranty. Pam Anderson made a motion to approve the tenting of buildings 400, 800, 1300 and the clubhouse. Rae Poritz seconded it, and all voted to approve. Bldgs 400 and 800 will be done of 7/8 (weather permitting) and 1300 and clubhouse will be done on 6/26.

**DISCUSS OWNER MAINTAINENCE OF FLORIDA ROOMS:** Pam asked that all residents check the appearance of the outside of their Florida rooms, and do any painting, improvement, etc. that is needed. Florida room gutters should be checked and maintained by each owner.
